



## Portugal CUSTOMS REGULATIONS

### HOUSEHOLD GOODS AND PERSONAL EFFECTS

#### 1) SHIPMENTS ARRIVING FROM EU COUNTRIES:

##### DOCUMENTS REQUIRED:

- A) BY TRUCK: Packing list and CMR
- B) BY AIR: Packing list and photocopy of the passport, AWB
- C) BY SEA: Packing list, photocopy of the passport, OB/L & T2L

#### CARS, MOTORBIKES, BOATS:

##### DOCUMENTS REQUIRED:

- by road: original title of property and registration card with the driver
- by sea: originals as above with T2L

#### 2) SHIPMENTS ARRIVING FROM OTHER COUNTRIES (OUTSIDE EU)

- A) "CONSULATE CERTIFICATE " with packing list attached (written in Portuguese) with no values described, issued by the nearest Portuguese Consulate; our destination agent recommends not to mention 2nd residence in this certificate (if any)
- B) "RESIDENCE CERTIFICATE" (Atestado de residencia) obtained by client at the "Junta de Freguesia" of client's residence in Portugal, stating that client has been residing there for less than one year and mentioning also the date of client's arrival.
- C) Original or certified copy of client's passport (Can be done by Portuguese consulate at origin)
- D) Photocopy of VAT card (Cartão de contribuinte)
- E) Working Visa (For foreigners, non EEC citizens)

#### 3) REMARKS:

##### CARS, MOTOR BIKES, BOATS:

Original title of property and registration card must be in possession of the owners at least 6 months before arrival in Portugal; Portuguese or EEC citizens must issue a separated "certificate of baggage" only for the car. Only 1 car allowed, 2nd car if any will pay duties

##### PORTUGUESE DIPLOMATS:

Apply same documents as described above

##### FOREIGN DIPLOMATS (non Portuguese):

Embassy of client's country in Portugal must obtain a Diplomatic Franchise from the Portuguese Ministry of Foreign Affairs, before arrival of vessel in order to avoid delays at pier.

##### PETS:

Blood exam with certificate of healthy issued by a certified veterinarian, insertion of microchip, pet passport with vaccinations in order.

Certified copy of death certificate and will, allow duty free entry.

## GUNS:

Property title, certified issued by Portuguese Consulate, must be declare on certified of baggage

(Only hunt and civilian guns allowed)
